The Stewards have received a Report from the Sporting Director regarding the attire of a driver of car #88. Having considered the matter and heard from the Competitor and driver make the following decision:

**Driver and car No:** Jules Gounon #88

**Competitor:** Akkodis ASP Team

**Time (fact):** 16.30hrs (2<sup>nd</sup> July 2023)

**Session:** Podium

**Fact:** The clothing of driver Jules Gounon did not conform with the Graphical Charter


**Offence:** Breach of Article 22.5 of the of the Fanatec World Challenge Europe 2023 Sporting Regulations and Appendix 3 thereof

**Decision:** Fine of €1,000


**Reason:** The Stewards have noted from the report and photographic evidence that the race suit of driver Gounon worn at the televised podium ceremony did not conform with the Graphical Charter for the Event. The Stewards today (delegated by Stewards' Decision #265) have heard from Jules Gounon and a representative of the Competitor, Jérôme Policand. Jules Gounon explained that his race suit which did comply with the Graphical Charter was being laundered and that he had not expected to drive the car again in the race. Circumstances within the team meant that he again had to drive car #88 and, of necessity, used an old race suit which did not comply. The Stewards are satisfied that a breach has occurred and award the penalty cited above.

In accordance with Decision #265, the Stewards panel for this Decision is that of the Nürburgring round of the Fanatec World Challenge Europe 2023.


Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting, within the applicable time limits.


