### STEWARDS' DECISION

**To:** GRT - Grasser Racing Team

The Stewards, having received a report from the Race Director, have considered the following matter and determine the following:

**No. / Driver:** 163 - Marco MAPELLI

**Competitor:** GRT - Grasser Racing Team

**Time:** 22:56

**Session:** Night Practice

**Fact:** Exceeded the speed limit in the pit lane with a speed of 57.3 km/h

**Offence:** Breach of Article 33.4 and 34.11 of the Fanatec GT Challenge Europe powered by AWS Sporting Regulations, Article 12.2.1.j of the FIA International Sporting Code and Chapter IV Article 5c) of Appendix L to the Code

**Decision:** 400 € Fine

**Reason:** Timekeeping data shows that car 163 crossed the "PITIN" timing loop in the pit lane at a speed of 57.3 kph, thereby exceeding the 50 kph pit lane speed limit. The Stewards determine that this is a breach of Article 34.11 of the above regulations and impose the penalty specified in accordance with that Article.
