The following corrections and clarifications are made to the following articles:

47.1 e) Special Case CrowdStrike 24 Hours of Spa

The following paragraph is corrected as follows:

Any car which has started a Technical Pit Stop prior to the red flag must cease work at the moment the red flag is shown and work may not recommence until Parc Fermé conditions are lifted. The car must then remain in the pit lane in the same place until the balance of the 5-minute Technical Pit Stop time has resumed and been completed, commencing from the moment the race resumes behind the Safety Car. Any questions concerning cars which were already in the pit lane before the red flag will be checked by the Race Director after the restart and any unauthorised work will be reported to the Stewards.

"Short" refuelling stops

Maximum fuel nozzle connection time: 3 seconds

Article 20.1.2 – Driving Stints:

In accordance with Article 20.1.2 of the Fanatec GT World Challenge Europe powered by AWS Sporting Regulations 2024, the Stewards confirm the following Driving Stints:

MDS - 62 minutes - 61 Minutes

EDS - 67 minutes - 66 Minutes

Emergency Stop according to article 46.9 of the Sporting Regulations

Maximum fuel nozzle connection time: 3 seconds
