The Stewards, having received a report from the Race Director and reviewed Timekeeping evidences, have considered the following matter and determine the following:

No. / Driver: 19 - Dante Rappange

Competitor: GRT - Grasser Racing Team

Time: 18:32:41

Session: Pre-Qualifying

Fact: Exceeded the speed limit in the pit lane with a speed of 50.1km/h

Offence: Breach of Article 27.4 and 28.11 of the GT World Challenge Europe powered by AWS 2025 Sporting Regulations, Article 12.2.1.j of the FIA International Sporting Code and Chapter IV Article 5c) of Appendix L to the Code

Decision: 50€ Fine

Reason: Timekeeping data shows that car 19 crossed the "PITSPD" timing loop in the pit lane at a speed of 50.1kph, thereby exceeding the 50 kph pit lane speed limit. The Stewards determine that this is a breach of Article 28.11 of the above regulations and impose the penalty specified in accordance with that Article.
